POLICY OF INSURANCE

Underwriters will, subject to the terms, exceptions and conditions contained herein and/or endorsed hereon underwriters will indemnify the insured against "All Risks" of loss or damage to the property arising after the property insured enters the custody or control of the carrier, during the course of transit or storage and until delivery or the expiry of 30 days from the date of collection, whichever occurs first unless additional cover is requested and an additional premium paid. Excluding loss, damage or expense proximately caused by delay or inherent vice or nature of the property insured.

UNDERWRITERS LIABILITY SHALL:

- (a) not exceed the sum insured reflected on the certificate issued or,
(b) R350 000 (three hundred and fifty thousand rand) whichever is lesser.
- be based on new replacement value;
- be subject to proof of removal and substantiation of value.

Underwriters may at their option repair, reinstate or replace any property lost or damaged or pay the amount of the loss or damage.

GENERAL CONDITIONS:

- The carrier shall prior to or at the time of despatch of each and every transit issue an insurance certificate and account to underwriters for the premium.
- The due observance and fulfilment of the terms, provisions, conditions and endorsements hereto/hereon insofar as they relate to anything to be done or complied with by insured or the carrier shall be conditions precedent to any liability of underwriters to make any payment under any certificate.
- This policy may be cancelled at any time on giving 60 days notice in writing but this notice will not apply to insurance certificates issued prior to the expiry of such notice.
- If at the time of the happening of any occurrence covered by this policy there is any other existing insurance whether effected by the insured or not covering the same loss, damage or liability then underwriters shall not be liable to pay or contribute more than their rateable proportion of any such loss or damage.
- Underwriters liability and then sum insured in respect of the following categories:
 - China, crockery, glass, earthenware, mirrors, pictures and paintings, gramophone records, compact disks and other fragile articles is restricted to 20% (Twenty Percent) of the total value for which the household is insured.
 - Antiques are restricted to 20% of the total value for which the household is insured. Unless increased by the payment of the appropriate additional premium.
- Where motor cycles form part of a domestic household removal there is no cover whilst the motor cycle moves under its own power.
- If at any time of any loss or damage occurring the property covered shall be collectively of greater value than the sum insured thereon, the insured shall be deemed to be his own insurer for the difference and shall bear a rateable proportion of the loss accordingly.
- Where an insured item consists of an article in a pair or set underwriters shall not be liable for more than the value of any particular part or parts which may be lost or damaged more than the proportionate part of the pair or set, without reference to any special value which such article or articles may have as part of such pair or set.
- Any one item in excess of R 1 000 (one thousand rand) must be specified.
- Cover is granted on the understanding that all material facts and particulars have been disclosed to the underwriters and shall be voidable at the option of underwriters should this not be the case or should it transpire that the risk has been misrepresented or misdescribed. The carrier shall at all times keep accurate records containing all the relevant particulars and shall at all times allow underwriters and/or their agents to inspect such records. The carrier shall notify the brokers as soon as possible of any alteration or increase in any risk(s) declared and insured under this certificate.
- The insured and the carrier shall take all reasonable steps and precautions to ensure the maintenance and safety of any property insured and/or to prevent accidents or losses arising.
 - The insured shall notify AON S.A. (PTY) LTD (Insurance Brokers) within seven days of any event which could give rise to a claim and shall as soon as is practicable deliver to the brokers at his own expenses full details of the claim in writing as required together with details of any other insurances covering the same risk or any part thereof. If the claim arises out of any criminal act he shall advise the police as soon as such act comes to his notice.
 - The insured and/or the carrier shall produce and furnish to underwriters all such books, records and other evidence as underwriters may require for the investigation and/or negotiation of any claim and shall give them all such assistance as they may require.
 - The carrier shall not repudiate any claim without the insurers written consent and shall send to the brokers immediately any letter, writ, summons or other legal process received.
 - If any claim be in any respect fraudulent or if any fraudulent means or devices be used by the insured or anyone acting on his behalf or if any destruction, injury or damage be occasioned by wilful act or with the connivance of the insured all benefit under the relevant insurance certificate shall be forfeited.
 - In the event of a dispute arising in connection with any claim under this insurance the insured shall submit any amount in dispute to arbitration and shall commence court action in the event of a denial of liability by underwriters within six months of underwriters having made an offer of final settlement or having denied liability failing which the insured shall forfeit all rights to enforce such claim. Arbitration shall be in accordance with the statutory provisions for the time being in force applicable thereto and the obtaining of any award shall be a condition precedent to any right of action against the insurers.
 - No claim under this policy (or certificate issued) shall be payable:
 - unless the terms of this condition have been complied with;
 - for any loss or damage after the expiry of twelve months from the happening of such loss or damage unless the claim is the subject of pending legal action.

- Any notice or communication to underwriters required by any condition of the policy (or any certificate issued) must be sent in writing by post to

and underwriters shall not be affected with notice of any circumstances not so communicated.

GENERAL EXCEPTIONS

This policy does not cover:

- loss, destruction or damage occasioned by or through or in consequence directly or indirectly of any of the following occurrences:
 - civil commotion, labour disturbances, riot, strike or lockout;
 - war, invasion, act of foreign enemy, hostilities or warlike operations (whether war be declared or not) or civil war;
 - i) mutiny, military rising, insurrection, military or usurped power, martial law or state of siege, or any other event or cause which determines the proclamation or maintenance of martial law or state of siege;

(ii) insurrection, rebellion or revolution.
 - any act (whether on behalf of any organisation, body or person, or group of persons) calculated or directed to overthrow or influence any state or government, or any provincial, local or tribal authority with force, or by means of fear, terrorism or violence;
 - any act which is calculated or directed to bring about loss or damage in order to further any political aim, objective or cause, or to bring about any social or economic change, or in protest against any state or government or any provincial, local or tribal authority, or for the purpose of inspiring fear in the public or any section thereof;
 - any attempt to perform any act referred to in clause (d) or (e) above;
 - the act of any lawfully established authority in controlling, preventing, suppressing or in any other way dealing with any occurrence referred to in clause (a), (b), (c), (d), (e) or (f) above.

If the insurer alleges that by reason of clause (a), (b), (c), (d), (e), (f) or (g) of this exception, loss or damage is not covered by this certificate, the burden of proving the contrary shall rest on the insured.

- Loss or damage cause directly or indirectly by or through or in consequence of any occurrence for which a fund has been established in terms of the War Damage Insurance and Compensation Act, 1976 (no 85 of 1976).
- NUCLEAR EXCLUSION
 - Any loss, destruction or damage whatsoever;
 - Any legal liability of whatsoever nature;

directly or indirectly caused by or arising from or in consequence of or contributed to by nuclear weapons material or by ionising radiations or contamination by radio-activity from any nuclear fuel or from any nuclear waste from the combustion of nuclear fuel. For the purpose of this exception only combustion shall include any self-sustaining process of nuclear fission.
- Mechanical derangement not caused by an accident to the conveying vehicle unless specifically insured.
- Loss, damage, destruction or deterioration caused by any gradually operating cause (including rust, corrosion and the action or light) wear and tear, mildew, insects, moth, vermin inherent vice or any process of cleaning, dyeing, repairing or restoring.
- Documents of any kind whether negotiable or not, money, stamps, medals, coins, models, moulds, patterns or designs. The term documents shall include but not be limited to deeds, bonds, titles, bills of exchange, promissory notes, cheques, securities for money, manuscripts, plans, books of accounts and travel tickets.
- Television sets unless specified on the relevant insurance certificate and an agreed additional premium paid.
- OWNER PACKED GOODS

Loss or damage to any article not packed by the Carrier unless caused by fire, collision or overturning of the conveying vehicle. However to include non-delivery of an entire transport package (carton, case or such like).
- Jewellery, watches, precious stones, precious metals, bullion, liquor, wine, perishable foodstuffs, groceries, cameras, binoculars, spectacles, animals, fire-arms, ammunition, explosives, poplants and motor cars.
- Loss or damage due to delay, confiscation or detention by customs or other officials or authorities or loss or market or consequential loss of whatever nature.
- The first R1 000 of any claim.
- Loss or damage to appliances/equipment due to such appliance/equipment not being prepared for transit in accordance with the manufacturers recommendations.

RIOT, STRIKE AND MALICIOUS DAMAGE

- Strikers, locked out workmen or persons taking part in labour disturbances, riots or civil commotions.
- Any terrorist or any person acting from a political motive as more particular described and excepted in the Institute Strike Clauses (Cargo) 1/182 insofar as they apply.
- The act of any lawfully established authority in controlling, preventing, suppressing or in any way dealing with any occurrence referred to in (i) above.
- The deliberate or wilful or wanton act of any person committed with intention of causing such loss or damage, but excluding loss or damage caused by or arising from theft or any attempt thereat.

Provided that this extension does not cover:
 - consequential or indirect loss of any kind or description whatsoever, other than loss of rent if specifically insured.
 - loss or damage resulting from total or partial cessation of work, or the retarding or interruption or cessation of any process or operation.
 - loss or damage occasioned by permanent or temporary dispossession resulting from confiscation, commandeering or requisition by any Lawfully constituted authority.

If Insurers allege that by reason of provisos (a), (b) or (c) loss or damage is not covered by this Policy the burden of proving the contrary shall rest on the Insured.
